Dear parents,

KinderBOKU is organizing **summer holidays** for **school children** of **BOKU members** (born in 2013 or later) for the first three weeks of school holidays in Vienna this year, from **July 1st to July 19th 2024**. Due to the high demand last year, we are able to offer more places this year **thanks to the support of the Rectorate**.

Summer care takes place from **monday to friday from 8am to 4:30pm** at **Türkenschanze in Guttenberghaus**. In the second vacation week (**July 8th-12th**), if required, it is also available in **Muthgasse (MUG2)**.

The **costs** amount to **105€ per child and week** (including lunch) and will be invoiced afterwards.

KinderuniBOKU is scheduled for **July 8-12th, 2024**. Detailed information will follow in June.

The children will be supervised by the "**Flying Nannies**" of the Children's Office of the University of Vienna (supervision ratio 5:1), who will provide a varied program of fun and games and insights into exciting research topics, and will respond to the interests of the children.

Unfortunately, visits to swimming pools cannot take place for safety reasons. In the second week of the vacation, the focus of the program will be on **attending courses at KinderuniBOKU**.

The **binding registration** takes place **exclusively online until April 5th, 2024** and is reserved for **BOKU employees and BOKU students**.

Please complete a **separate online form for each child** and **confirm** the required **data protection information** and the **cancellation policy** at the end of the form.

The **registration is binding** as soon as you have sent the form. After checking the data you have put in and submitting the form, you will receive a **confirmation by e-mail**. This will contain a summary of your details as well as information on the summer holidays and the cancellation policy attached. You can no longer change the data you have entered.

The following applies:

- **binding registration** (cancellations see below) **by April 5th, 2024**
- only **weekly registrations** are possible, no single days
- **school children born in 2013 or later** can be registered

Please note our **cancellation policy**, to which you have given your consent at the end of the form.

Cancellation of a booking is only possible and valid in writing by e-mail to kinderboku_sommerferien@boku.ac.at

Cancellation policy:

- Up to 30 days before the first day of care: no fee
- 29-21 days before the first day of care: 25% of the costs
- 20-14 days before the first day of care: 50% of the costs
- less than 14 days before the date of care: 100% of the costs

We strive to make **registration** for the summer holidays **fair**. **If the demand exceeds the available places**, we will try to enable **as many children as possible to take part** in the summer holidays and, if necessary, reduce the number of weeks per child.
